In January, 2019, 3 trades with total value of AMD 1,111,830 were concluded in the equities market. 4,527 stocks of 2 issuers were traded. The trades were concluded only through manual trading mechanism.


Compared to the same period of the previous year (Jan-18) the number of trades, the number of stocks traded and the total value traded decreased by -82.353%, -97.909% and -99.501%, respectively.

As compared to the previous month (Dec-18) number of trades remained the same, and the number of securities traded and the total value traded increased by 1810.127% and 1249.308%, respectively.



Corporate Bonds

During January, 2019, trades in corporate bonds were concluded for a total value of AMD 1,911,621,575, of which AMD 1,625,008,403 equivalent to USD 3,336,910 were concluded in USD denominated bonds. Overall 57,293 bonds of 12 issuers were traded. The trades were concluded through continuous two-way auction, as well as manual trading mechanism.


Compared to the same period of the previous year (Jan-18) the number of trades and the total value traded increased by 119.697% and 104.704%, respectively, and the number of bonds traded decreased by -6.984%. As compared to the previous month the number of trades, the number of bonds traded and the total value traded decreased by -28.838%, -72.467% and -28.838%, respectively.

In January, 2019, 26 repo trades were concluded at Armenia Securities Exchange with total value traded of AMD1,015,345,614, AMD855,467,817 of which were concluded in USD denominated bonds.

As compared to the previous month, the number of trades and the total value traded decreased by -13.333% and -11.951%, respectively.

Government Bonds

In January, 2019, 555 trades in Government bonds were concluded with total value traded (by purchase price) of AMD 50,389,223,505. This month the trades were concluded only through continuous two-way auction trading mechanism. As compared to the previous month, the number of trades and the value traded (by purchase price) increased by 48.387% and 1.664%, respectively.

As compared to the same period of the previous year (Jan-18), the number of trades and the total value traded (by purchase price) decreased by -16.364% and -49.529%, respectively.

Ministry of Finance of RA granted ARARATBANK, ArdshinInvestBank, ArmSwissBank, Converse Bank, HSBC Bank Armenia, VTB BANK (Armenia) and AMERIABANK the status of government debt management agent to provide simultaneous bid and ask quotes of the following benchmark government bonds AMGN36294202, AMGN60294219, AMGN60294235, AMGB1029A276, AMGB2029A366 and AMGB30163472 in the trading system. To ensure implementation of this process Armenia Securities Exchange in its turn granted the above mentioned agents the status of market maker.




Overview of Depository Activities

As of January 31, 2019, 2,499 companies had their shareholder registries kept with the CDA.


