Equities Market

In January, 5 trades with total value of AMD 2,291,295 were concluded in the equities market. 774 stocks of 2 issuers were traded. The trades were concluded through continuous two-way auction, as well as manual trading mechanizm.

As compared to the previous month [December, 2016] the number of trades, the number of securities traded and the total value traded decreased by 37.50%, 97.61% and 71.35%, repectevily.



Corporate Bonds

During January, 2017, 37 trades in corporate bonds were concluded for a total value of AMD 298,415,242, of which AMD 295,505,719 equivalent to USD 607,412 were concluded in USD denominated bonds. Overall 7,391 bonds of 7 issuers were traded. The trades were concluded through continuous two-way auction, as well as manual trading mechanizm.


Compared to the same period of the previous year (January, 2016) the number of trades, the number of bonds traded and the total value traded increased 2.3, 1.79 and 6.52 times, respectively. As compared to the previous month the number of trades, the number of bonds traded and the total value traded decreased 2.62, 7.98 and 3.68 times, respectively.

Government Bonds

In January, 2017, 4 trades in Government bonds were concluded with total value traded (by purchase price) of AMD 205,800,000. As compared to the previous month, the number of trades and the value traded decreased 19.3 and 26.8 times, respectively.

As compared to the same period of the previous year (January, 2016), the number of trades decreased by 63.6%, while the value traded (by purchase price) increased by 13.8%.

Ministry of Finance of RA granted ARARATBANK, ArdshinInvestBank, ArmSwissBank, Converse Bank, HSBC Bank Armenia, VTB BANK (Armenia) and AMERIABANK the status of government debt management agent to provide simultaneous bid and ask quotes of the following benchmark government bonds AM6N36294186, AM6N36294194, AM6N60294219, AM6B1029A250, AM6B20172327, and AM6B2029A366 in the trading system. To ensure implementation of this process NASDAQ OMX Armenia in its turn granted the above mentioned agents the status of market maker.



Monthly Close and Weighted Average Prices of FX Trading in the Past 12 Months





As of January 31, 2017, 2,305 companies had their shareholder registries kept with the CDA.


