EXCHANGE TRADING

All financial figures are in Armenian Drams (AMD) unless otherwise noted. Exchange rates established by the Central Bank of Armenia as of July 31, 2018 were as follows: USD 1 = AMD 480.95, EUR 1 = AMD 563.82

Equities Market

In July, 2018, 11 trades with total value of AMD 234,314,864 were concluded in the equities market. 258,301 stocks of 3 issuers were traded. The trades were concluded through manual trading only. Compared to the same period of the previous year (July, 2017) the number of trades increased by 10.0%, and the number of stocks traded and the total value traded increased by 11.10 and 18.87 times, respectively.

As compared to the previous month (June, 2018) the number of trades, the total value traded and the number of securities traded increased by 2.20, 59.0 and 25.58, times respectively. Please refer to the table below for equities market exchange trading statistics in 2018 (by months).







Corporate Bonds

During July, 2018, 139 trades in corporate bonds were concluded for a total value of AMD 1,772,160,186, of which AMD 1,285,683,009 equivalent to USD 2,673,216 were concluded in USD denominated bonds. Overall 45,679 bonds of 13 issuers were traded. The trades were concluded through continuous two-way auction, as well as manual trading mechanizm.


Compared to the same period of the previous year (July, 2017) the number of bonds traded decreased by 18.17%, while the number of trades and the total value traded increased by 183.7%, and 65.10.%, respectively. As compared to the previous month the number of trades, the number of bonds traded and the total value traded increased by 31.13%, 8.15% and 61.02%, respectively.


REPO/SWAP Trading


As compared to the same period of the previous year (July, 2017), the number and the total value traded inceased by 255.6% and 332.5%, respectively.



Monthly Close and Weighted Average Prices of FX Trading in the Past 12 Months






